Irving</p>	<p>your child (and other pupils with SEND in the school) achieve the best possible progress in school.</p> <p>A Teaching Assistant (TA) may be allocated to a pupil with exceptional special educational needs and/or disabilities and whilst they take a very valuable role in your child's education we would prefer that questions regarding your child's learning and progress are directed initially to the class teacher and/or SENCo.</p> <p>Of course, as a school we welcome dialogue between parents and TAs on how a child's day has been and we do actively encourage this continued feedback.</p> <p><b>She is responsible for:</b></p> <ul style="list-style-type: none"><li>• The day to day management of all aspects of the school, this includes the support for children with SEND.</li><li>• She will give responsibility to the SENCo and class teachers but is still responsible for ensuring that your child's needs are met.</li><li>• She must make sure that the Governing Body is kept up to date about any issues in the school relating to SEND.</li></ul> <p><b>She is responsible for:</b></p> <ul style="list-style-type: none"><li>• Making sure that the school has an up to date SEND policy</li><li>• Making sure that the school has appropriate provision and has made necessary adaptations to meet the needs of all children in the school</li><li>• Over seeing the necessary support that is made for any child who attends the school who has SEN and/or disabilities</li><li>• Making visits to understand and monitor the support given to children with SEND in the school and being part of the process to ensure your child achieves his/her potential in school.</li></ul>

**B. HOW COULD MY CHILD GET HELP IN SCHOOL? :**

Children in school will get support that is specific to their individual needs. This may all be provided by the class teacher or may involve:

- Other staff in the school
- Staff who will visit the school from the Local Authority central services such as the ASC Autistic Spectrum Condition, Outreach Team or Sensory Service ( for students with a hearing or visual need)
- Staff who visit from outside agencies such as the Speech and Language therapy (SALT) Service.

This may involve things like using more practical learning or providing different resources adapted for your child</li> <li>• Putting in place specific strategies (which may be suggested by the SENCo or outside staff) to support your child to learn.</li> </ul>	All children in school should be getting this as a part of excellent classroom practice when needed.

	<p>Graduated Response-  <b>Specific group work within a smaller group of children. This will help the school and yourself understand your child’s particular needs better and be able to support them better in school.</p> <ul style="list-style-type: none"> <li>• The specialist professional will work with your child to understand their needs and make recommendations, which may include: <ul style="list-style-type: none"> <li>○ Making changes to the way your child is supported in class e.g. some individual support or changing some aspects of teaching to support them better</li> <li>○ Support to set better targets which will include their specific expertise</li> <li>○ A group run by school staff under the guidance of the outside professional e.g. a social skills group or sensory circuit</li> <li>○ A group or individual work with outside professional</li> </ul> </li> <li>• The school may suggest that your child needs some agreed individual support in school. 	<p><b>Statement of Special Educational Needs or an Education, Health and Care Plan (EHCP).</b> This means your child will have been identified by the class teacher/SENCo as needing a <b>particularly high level of individual or small group teaching (more than 15 hours a week)</b>, which cannot be provided from the budget available to the school.</p> <p>Usually your child will also need specialist support in school from a professional outside the school. This may be from:</p> <ul style="list-style-type: none"> <li>• Local Authority School Inclusion Team</li> <li>• Outside agencies such as the Speech and Language therapy (SALT) Service.</li> <li>• SENSS, who support children with communication and language, sensory needs and physical needs</li> <li>• Behaviour Support</li> </ul>	<p>Oxfordshire website:  <a href="https://www.oxfordshire.gov.uk/cms/public-site/special-educational-needs-and-disability-send">https://www.oxfordshire.gov.uk/cms/public-site/special-educational-needs-and-disability-send</a></p> <ul style="list-style-type: none"> <li>• After the school have sent in the request to the Local Authority (with a lot of information about your child, including some from you), they will decide whether they think your child’s needs (as described in the paperwork provided), seem complex enough to need a statutory assessment. If this is the case they will ask you and all professionals involved with your child to write a report outlining your child’s needs. If they do not think your child needs this, they will ask the school to continue with the support at School Action Plus.</li> <li>• After the reports have all been sent in the Local Authority will decide if your child’s needs are severe, complex and lifelong and that they need more than 15 hours of support in school to make good progress. If this is the case they will write a Statement of Special Educational Needs or an EHC Plan. If this is not the case, they will ask the school to continue with the support at School Action Plus and also set up a meeting in school to ensure a plan is in place to ensure your child makes as much progress as possible.</li> <li>• The Statement or EHC Plan will outline the</li> </ul>	<ul style="list-style-type: none"> <li>• Need more than 15 hours of support in school</li> </ul>

<p>How will we support your child with identified special needs starting at school?</p>	<ul style="list-style-type: none"> <li>• We will first invite you to visit the school with your child to have a look around and speak to key staff (Head Teacher/SENCo)</li> <li>• If other professionals are involved, a Team Around the Child (TAC) meeting or Multi-agency meeting will be held to discuss your child's needs, share strategies used, and ensure provision is put in place before your child starts</li> <li>• Your child's key person may make a home visit and also visit your child if they are attending another education provider</li> <li>• We may suggest adaptations to the settling in period to help your child settle more easily.</li> </ul>		
<p>How can I let the school know I am concerned about my child's progress in school?</p>	<ul style="list-style-type: none"> <li>• If you have concerns about your child's progress you should speak to your child's class teacher initially.</li> <li>• If you are not happy that the concerns are being managed and that your child is still not making progress you should speak to the SENCo or Headteacher</li> <li>• If you are still not happy you can speak to the school SEND Governor.</li> </ul>		
<p>How will the school let me know if they have any concerns about my child's learning in school?</p>	<ul style="list-style-type: none"> <li>• When a teacher or a parent has raised concerns about your child's progress, and targeted teaching has not met the child's needs, the teacher must raise this with the SENCo.</li> <li>• School also has meetings every term between each class teacher and the Headteacher to ensure all children are making good progress. This is another way your child may be identified as not making as much progress as they could be.</li> <li>• If your child is then identified as not making progress the school will set up a meeting to discuss this with you in more detail or send you a concern sheet             <ul style="list-style-type: none"> <li>○ To listen to any concerns you may have too</li> </ul> </li> </ul>

<p>How is extra support allocated to children and how do they move between the different levels?</p>	<ul style="list-style-type: none"> <li>● The school budget, received from Oxfordshire LA, includes money for supporting children with SEND.</li> <li>● The Head Teacher decides on the budget for Special Educational Needs in consultation with the school governors, on the basis of needs in the school.</li> <li>● The Head Teacher and the SENCo discuss all the information they have about SEND in the school, including             <ul style="list-style-type: none"> <li>○ the children getting extra support already</li> <li>○ the children needing extra support</li> <li>○ the children who have been identified as not making as much progress as would be expected.</li> </ul> <p>And decide what resources/training and support is needed.</p> </li> <li>● All resources/training and support are reviewed regularly and changes made as needed.</li> </ul>

<p>How are the teachers in school helped to work with children with a SEND and what training do they have?</p>	<ul style="list-style-type: none"> <li>• The SENCo's job is to support the class teacher in planning for children with SEND.</li> <li>• The school has a training plan for all staff to improve the teaching and learning of children including those with SEND. This includes whole school training on SEND issues such as ASC, dyslexia etc</li> <li>• Whole staff training to disseminate knowledge, strategies and experience, to ensure consistency of the school's approach for children with a SEND.</li> <li>• Individual teachers and support staff attend training courses run by outside agencies that are relevant to the needs of specific children in their class e.g. from the ASC Outreach service and Sensory service.</li> </ul>	
<p>How will the teaching be adapted for my child with learning needs (SEND)?</p>	<ul style="list-style-type: none"> <li>• Class Teachers plan lessons according to the specific needs of all groups of children in their class, and will ensure that your child's needs are met.</li> <li>• Specially trained support staff can adapt the teacher's planning to support the needs of your child where necessary.</li> <li>• Specific resources and strategies will be used to support your child individually and in groups.</li> <li>• Planning and teaching will be adapted on a daily basis if needed to meet your child's learning needs.</li> </ul>	
<p>How will we measure the progress of your child in school?</p>	<ul style="list-style-type: none"> <li>• Your child's progress is continually monitored by his/her class teacher.</li> <li>• His/her progress is reviewed formally every term and results are recorded on our school tracking system.</li> <li>• If your child is in Year 1 and above, but is not yet at the equivalent of National Curriculum levels, a more sensitive assessment tool is used which shows their attainment in more detail and will also show smaller but significant steps of progress. The levels are called 'P levels'.</li> <li>• At the end of each key stage (i.e. at the end of Year 2 and Year 6) all children are required to be formally assessed using Standard Assessment Tests (SATs). This is something the government requires all schools to do and the results are published nationally.</li> </ul>

	<ul style="list-style-type: none"><li>• Children at School Action and School Action Plus will have an IEP which will be reviewed with your involvement, every long term and the new plan for the next term will then be made.</li><li>• The progress of children with a statement of SEND/ EHC Plan is formally reviewed at an Annual Review with all adults involved with the child's education.</li><li>• The SENCo will also check that your child is making good progress within any individual work and in any group that they take part in.</li><li>• A range of ways will be used to keep you informed, which may include:<ul style="list-style-type: none"><li>– Home/school contact book</li><li>– Additional meetings as required</li><li>– Reports</li></ul></li></ul>
What support do we have for you as a parent of child with an SEND?	<ul style="list-style-type: none"><li>• We would like you to talk to your child's class teacher regularly so we know what they are doing at home and we can tell you about what we are doing in school. We hope this will make sure that we are doing similar things to support your child both at home and school and can share what is working in both places.</li><li>• The SENCo (or Head teacher) is available to meet with you, by appointment, to discuss your child's progress or any concerns/worries you may have.</li><li>• All information from outside professionals will be discussed with you with the person involved directly, or where this is not possible, in a report. The SENCo will also arrange to meet with you to discuss any new assessments and ideas suggested by outside agencies for your child.</li><li>• IEPs will be reviewed with your involvement three times a year.</li><li>• Home learning projects will be adjusted as needed to your child's individual needs</li><li>• A home/school contact book may be used to support communication with you, when this has been</li></ul>

	<p>agreed to be useful for you and your child.</p> <p>In addition: If your child is undergoing statutory assessment you will also be supported by the Oxfordshire SEND Assessment Team. They will ensure that you fully understand the process.</p>
<p>How have we made our school accessible to children with SEND? (including after school clubs etc..)</p>	<ul style="list-style-type: none"> <li>• The school is accessible to children with physical disability via ramps.</li> <li>• We ensure that equipment used is accessible to all children regardless of their needs.</li> <li>• Enrichment activities are extended to all pupils irrelevant of their needs</li> </ul>
<p>What is the pastoral, medical and social support available in the school?</p>	<ul style="list-style-type: none"> <li>• We are an inclusive school; we welcome and celebrate diversity. All staff believe that children having high self-esteem is crucial to a child's well-being. We have a caring, understanding team looking after our children.</li> <li>• The class teacher has overall responsibility for the pastoral, medical and social care of every child in their class, therefore this would be the parents' first point of contact. If further support is required the class teacher liaises with the SENCo for further advice and support. This may involve working alongside outside agencies such as Health and Social Services, and/or the Behaviour Support Team/Educational Psychologist.</li> </ul>
<p>What support is there for managing pupil behaviour and increasing pupil attendance?</p>	<ul style="list-style-type: none"> <li>• As a school we take a positive approach to all types of behaviour and we have a clear reward system that is followed by all staff and pupils.</li> <li>• If a child has behavioural difficulties an Individual Behaviour Plan (IBP) is written with the child and parents to identify the specific issues, put relevant support in place and set manageable behaviour targets.</li> <li>• After any behaviour incident we expect the child to reflect on their behaviour with an adult; this is recorded on a 'Think Sheet'. This helps to identify why the incident happened and what the child needs to do differently next time to change and improve their behaviour.</li> <li>• Attendance of every child is monitored on a daily basis by the office staff. Lateness and absences are</li> </ul>

	<p>recorded and reported to the Business Manager and/or Head teacher who will work closely with the parents to ensure increase in attendance and reduced lateness if needed. The school will involve the Attendance and Engagement Officer if necessary.</p>
<p>How will my child be able to contribute their views?</p>	<ul style="list-style-type: none"> <li>• We value and celebrate each child being able to express their views on all aspects of school life. This is usually carried out through the School Council which has an open forum for any issues or viewpoints to be raised.</li> <li>• Children who have IEPs (Individual Education Plans) discuss and set their targets with their class teacher and assess the progress made for the previous targets.</li> <li>• If your child has a Statement of SEND their views will be sought before any review meetings.</li> </ul>
<p>How will we support your child when they are leaving this school? OR moving on to another class?</p>	<p>We recognise that ‘moving on’ can be difficult for a child with SEN and take steps to ensure that any transition is as smooth as possible.</p> <ul style="list-style-type: none"> <li>• If your child is moving to another school:             <ul style="list-style-type: none"> <li>○ We will contact the school SENCo and ensure he/she knows about any special arrangements or support that needs to be made for your child.</li> <li>○ We will make sure that all records about your child are passed on as soon as possible.</li> </ul> </li> <li>• When moving classes in school:             <ul style="list-style-type: none"> <li>○ Information will be passed on to the new class teacher in advance and a planning meeting will take place with the new teacher. All IEPs will be shared with the new teacher.</li> <li>○ If your child would be helped by a book to support them understand moving on then it will be made for them.</li> <li>○ Extra visits will be arranged when appropriate.</li> </ul> </li> <li>• In Year 6             <ul style="list-style-type: none"> <li>○ The SENCo will arrange a date to discuss the specific needs of your child with the SENCo of their secondary school, as appropriate.</li> <li>○ Your child will attend a small group in school, to support their understanding of the changes ahead. This may include creating a ‘Personal Passport’ which includes information about themselves for their new school.</li> </ul> </li> </ul>
